I'm writing to follow up on Sarah's email below as well as our conversation at the 11/16 SDWA Short-Term Solutions workgroup meeting.

Per our conversation—and please don't hesitate to correct me if I have incorrect notes—DNR agrees that 738 funds can be used for manure contamination of a well with bacteria. MEA, on behalf of the SDWA Petitioners, requests DNR legal option regarding applicability of these funds for nitrate-only pollution in areas of special eligibility. Sarah also reminded me that as long as we're asking for an opinion, it would make sense to ask the same question of viruses that result from manure contamination. MEA will work on a memo with the goal of having a separate call and/or meeting with you before the next short-term solutions workgroup meeting.

We are happy to attend an in-person meeting but are also confident that we could provide you with something in writing and have you convey that opinion to DNR legal. Let us know what you prefer.

HI Kyle,

I just wanted to add a bit to the comment that I raised about ch NR 738. Sorry for throwing that out there without a prior heads up, but I just didn't want to forget about it, and I thought it was an interesting opportunity. I'm just sending this to you for now for your consideration, but hopefully we could discuss it next time.

The way that I read the spills law, I think that it and ch. 738 would apply to a manure contamination of a well. Manure fits the definition of of a hazardous substance in 292 once it enters groundwater. And applicability of 738 is tied back to the spills law. The spills law applies to a discharge of a hazardous substance. There are exemptions for those with a 283 permit, but that is only an exemption from penalty and notification requirements of 292, it doesn't make it inapplicable.

So I think there is a solid argument that NR 738 applies. NR 738 funding isn't available for wells that are only contaminated with bacteria or nitrates EXCEPT if the well is in an area of special eligibility, see NR 738.13(7) and 738.06(1m).

I think it would be useful to get a better understanding of the DNR staff and legal interpretation of this provision and also if there are ways that the DNR can make it easier to get areas of special eligibility designated. I know you all are working on that, but maybe there

are ways we could talk about streamlining.
