FINDINGS OF FACT

- 1. On October 29, 2014, the State of Wisconsin, Division of Hearings and Appeals (DHA) issued a decision in the above-captioned matter which had been conducted as a contested case proceeding.
- 2. On November 18, 2014, Kinnard Farms, Inc., filed a Petition for Review by the Secretary ("the petition") of the decision in the above-captioned matter pursuant to Wis. Admin. Code § NR 2.20, by personally delivering the petition to the Office of the Secretary.

CONCLUSIONS OF LAW

- 1. The petition was filed within the time required by Wis. Admin. Code § NR 2.20(1) and served upon the Wisconsin Department of Natural Resources (DNR) in compliance with Wis. Admin. Code § NR 2.03.
- 2. Wis. Admin. Code § NR 2.20 provides the Secretary of the DNR the discretionary authority to review contested case decisions.
- 3. The issues raised in the petition primarily concern the sufficiency of DNR's legal authority to impose certain disputed conditions in Kinnard Farm's Wisconsin Pollutant Discharge Elimination System (WPDES) wastewater discharge permit. Those and all other issues identified in the petition are amenable to judicial review in circuit court pursuant to Wis. Stat. § 227.52, et seq.

ORDER

Because I believe that the issues raised in the petition would most appropriately decided by the courts of this state in proceedings for judicial review, I respectfully decline to grant Secretarial review of the October 29, 2014, 2014 decision in the above-captioned matter.
